Biographical Notes:

Anne Longfellow, sister of poet Henry Wadsworth Longfellow, was born in Portland in 1810. In 1832 she married George Washington Pierce, a lawyer who had worked with her father and was a classmate of Henry Wadsworth Longfellow at Bowdoin College. He died three years later. Anne bequeathed the Wadsworth-Longfellow House in Portland to the Maine Historical Society. She died in Portland in 1901. Mary Longfellow, sister of Anne Longfellow Pierce and Henry Wadsworth Longfellow, was born in Portland in 1816. In 1839 she married James Greenleaf, a Dartmouth graduate and commission merchant, who worked in the cotton industry in New Orleans. Mrs. Greenleaf died in 1902 in Cambridge, Massachusetts. Nathaniel Deering was a Portland businessman, born in 1791. He was a Harvard graduate, writer, and lawyer, who married Anna Margaret Holwell in 1824. They had nine children, seven of whom survived infancy. He died in Portland in 1881. George A. and Charles F. Alden are the children of Darius and Bethiah Alden of Augusta, Maine. Darius was a hatter. The two boys were born ca. 1848 and 1849. During his life, George lived in Maine and Massachusetts, working for a railroad. He and his wife Mary had two children, Jennie and Payson.

Scope and Content:

The collection is made up of correspondence and documents relating primarily to the Alden and Deering families, but also containing postcards and envelopes addressed to or sent from Maine residents in the second half of the 19th century, especially Henry Wadsworth Longfellow and his family members. Highlights of the correspondence include letters written to George Alden from his brother Charles between 1900 and 1902, and requests sent to the Virgin City Stamp Company. The collection also contains Nathaniel Deering's insurance documents, a small stamp collection, and other related papers.
